Reason for Arrest

Indicate below reason for arrest or your testimony and provide facts that establish the identity of the suspect and each element of the crime. Indicate what you/ victims/ witnesses can testify to.

On December 6th, 2025, the victim, Frezja Matisse Baker, was reported as a Missing Person by her family to the Charlotte-Mecklenburg Police Department. The family last spoke to the victim over the phone on December 4th, 2025 at approximately 2230 hrs. The victim's family reported they could hear the victim's boyfriend on the phone when they spoke with her. Her boyfriend was identified as Lorenza Inman 09-17-1987. The victim had dropped her son off with family in the afternoon on December 4th, 2025 and had not returned or contacted anyone since the evening on December 4th, 2025.

Missing Persons Detectives opened an investigation into Frezja's disappearance. Detectives obtained Frezja's phone and financial records. Detectives identified Frezja and Lorenza on video at the Mobil gas station located at 1323 Lasalle St., Charlotte, NC 28216 on December 4th, 2025 at approximately 2148 to 2152 hrs. They arrive in the victim's vehicle, a blue/gray Honda Accord, and Frezja enters the store first. Lorenza follows her and puts his right hand on the back of the victim's head/neck and pushes her a few feet into a display, hard enough to twist her head down and to the right. The victim then starts to walk toward the coolers at the back of the store. Lorenza shoves Frezja with his right hand on the back of her neck causing her to stumble forward. Lorenza then towers over the victim as her back is against the cooler doors and she is facing him. The victim grabs items from the cooler and starts to walk toward the register. Lorenza throws a hand sized item hard with his right hand, striking the victim in the back. They exit the store and Frezja gets into the front passenger seat of her car. Lorenza gets into the driver seat of the car and the vehicle leaves. Detectives reviewed the victim's phone records and saw that one of the numbers stops activity around 2230 hrs. on December 4th, 2025. The other number provided stops activity after 0800 hrs. on December 5th, 2025.

On December 9th, 2025, Detectives received a Crime Stoppers tip advising that "Nuna" had said the victim was already dead, had been shot in the head, and was sitting in the passenger side inside of her vehicle. Detectives were directed to search in the Brookshire wood area and behind buildings.


On December 11th, 2025, the victim's vehicle was located behind a church located at 2300 Sanders Ave., Charlotte, NC 28216 by Metro Division Officers. The victim was located deceased in the front passenger seat and was suffering from apparent head trauma. She was pronounced deceased by Ofc. Mohrman #5955 at 0938 hrs. She was wearing the same clothing as she was seen on the Mobil gas station video from December 4th, 2025. A jacket was covering her chest. Detectives canvassed for video in the area of the church. A residence across the street from the church provided video clips from December 4th and 5th, 2025. The video from the afternoon of December 4th, 2025 at 1703 hrs. shows that a vehicle was not parked behind the church. The video from December 5th, 2025 at 0820 hrs. shows a vehicle consistent with the victim's vehicle parked where the victim's vehicle was located.

Detectives were contacted by the North Carolina Department of Adult Corrections. Lorenza's Probation Officer was contacted by a known witness on December 9th, 2025. The Probation Officer advised that she was informed that "Ya'll looking for Frezja Baker and that girl is dead, I don't know where her body is at, but her car is parked somewhere near my house. Lorenza told me that they got into an argument, the gun went off, and she was shot in the head".

Detectives spoke with the known witness in person. The known witness is familiar with Lorenza and identified a single photo of him. The witness knows Lorenza as "Nuna". The witness stated that on December 7th, 2025, Lorenza told the witness that he killed somebody. He told the witness that he was trying to put a gun on the back seat of the vehicle and the victim grabbed for the gun and the gun went off. The victim was left in her car nearby and a jacket was put on her head. This information is consistent with the scene and would only be known by someone with intimate knowledge of the scene. The witness saw Lorenza on December 5th, 2025, at approximately 0100 hrs. enter 2036 Renner St., Charlotte, NC 28216. Lorenza was in the residence for a short period of time and left shortly after.

Detectives are seeking charges for Murder, Assault on a Female, and Misdemeanor Crime of Domestic Violence
