**MOTION FOR CONTEMPT**  
For Rolesville Police Dept

Now comes the Defendant, pro se' and moves to hold the Rolesville Police Department in "**Contempt of Court**" in violation of Superior Court Order 22cv01444, pursuant to Chapter 5A, Article 2. Civil Contempt., G.S. §A-23 Proceedings for Civil Contempt and Rolesville Police Dept., Chief David Simmons (not Sheriff) who's in charge of the police station must be held in "Contempt of Court" until all of the following has been delivered to the Superior Court, Justice Center on 10 Floor or send to the Defendant address, in accordance with Judge Shirley 2/8/22, 2/17/22, and 2/24/22 signed Orders under 22cvd01444 and Judge Rozier 2/24/22 signed Order under 22cvd001444.

- Defendant decree, as of today 3/18/22 absolutely no evidence and/or any additional documentations have been turned to the Defendant regarding the proof of whether or not the 3/3/21 three Officers BodyCam videos were actually purged.
  - o Or whether Simmons tried to retrieve the video back from either the I.T. Svc Company or the Body-Worn Camera Company, as written on the form because no additional documentation was attached.
  - o Chief Simmons did not attach any documents or proof illustrating the opposite occurred. Defendant received 1 page of the Transmittal of Law Enforcement Agency Recording (LEA Recording Transmittal Form) Form, only.

- 1) Plaintiff is a citizen of Wake County, State of NC.
- 2) Defendant is a citizen of Wake County, State of NC.

The Rolesville PD has willfully and purportedly violated the terms and conditions signed by the Superior Court Judge Shirley on 2/8/22 and Judge Rozier on 2/24/22 in Order 22cvd01444, as follows:

- 1) Chief David Simmons of the Rolesville Police Dept should be held in "Contempt of Court" being the head of the police station until all of the vital evidence is turned over to the Justice Center for the Superior Court of Wake County or to the Defendant as order by Judge Rozier on 2/24/22.
- 2) Chief David Simmons has egregiously ignored and dully have just blandly refused to comply with Order 22cv01444 signed on 2/8/22, where Superior Court Judge Shirley Ordered the Rolesville Police Department (PD) to turn over "All" three (3) Officers' Bodycam Hacking - Confession Videos worn on 3/3/21 by Officer Jose Apodaca, Lt Courtney Williams and one other officer on the scene, when the video was captured at my home and "ALL" of 911 call logs (196 est. calls) from 12/31/19 YTD for defendants' address: 733 Strathwood Way, Rolesville NC 27571.
- 3) Chief David Simmons has egregiously ignored and dully have just blandly refused to comply with the signed Superior Court Judge Shirley 2/8/22 Order 22cv01444 for the Rolesville PD to turn over the officers three bodycam videos of the 3/3/21 Hacking - Confession Video and 911 Call Logs by 2/17/22 to the Superior Court Judges Office, 10<sup>th</sup> Floor, Justice Center for *in-camera* review.
- 4) Chief David Simmons has egregiously ignored and dully have just blandly refused to comply with and orders from the Superior Court and I don't think it made any difference that Judge Shirley Ordered the Rolesville PD to appear on a WebEx - Hearing on 2/24/22 with Superior Court Judge Rozier, because Chief Simmons is refusing anything and everything regarding this video to be turned over. Chief Simmons is refusing, period due to the nature of the comments from Michelle Larschield that the police officers drink up their alcohol and get in their pool as stated in the video.
- 5) Chief David Simmons has egregiously ignored and dully have refused to comply with Superior Court Judge Shirley Orders dated 2/24/22, and refused to even appear (and didn't show any objections to granting the release of the evidence...) on the WebEx Hearing on 2/24/22 in offense of his personal denial to comply to the Superior Courts order's for a hearing or for vital evidentiary information that the Chief is

holding; therefore, Superior Court Judge Rozier granted the Defendant an Order to be given "ALL" of the 3/3/21 Hacking - Confession Video from "ALL" three Officers of the Rolesville PD listed prior and "ALL" of the 196 calls to 911 from 12/31/19 YTD with supplemental Connnotes from each officer on the scene.

Those 4 Superior Court Orders written under 22cvd01444, made absolutely no difference to the Rolesville PD Chief Simmons that the Judicial Branch ordered them to turn over vital evidence or appear on a WebEx, because on 2/24/22 per LT Williams 'not even an act of God or Jesus himself, walking into the Rolesville Police station could make Chief Simmons turn over that Hacking - Confession video that implications' potentially him and his fellow officers. This Hacking - Confession Video in Michelle Larschiels voice and Craigs Larschiold describes how Rolesville Officers in grey uniforms help cover up crimes, that she thought her husband said all officers in grey uniforms were their friends and any crimes committed would be overlooked by these Officers; as well as other criminal activities made against me and my family. What happened to the 'Protect and Serve' motto?

The Chief has allowed and is allowing his friendship with ICG Homes Owner, Builder Ryan Perry and friendship with Craig and Michelle Larschiold of 729 Strathwood Way to come first, verse the governing law, or is it that the Chief doesn't want to go to jail himself for his personal acts roll in allowing these folks to get away with break-in a BLACK Handicapped and Disable (2 female) home with the master-key from my Builder Ryan Perry, over 3 dozen times and that's why the Chief won't turn over the Video nor the 196 calls to 911 for help because it will give the court a timeline of How, What, Where, When, and Who committed these crimes while on the clock pretending to protect and serve the community.

- 6) Chief Simmons has egregiously ignored and dully have refused these Orders and in response, he's merely said the video is purged but didn't offer the Superior Court Judges any evidence that the 3 Officer's BodyCam Video's from 3/3/21 were actually deleted and he merely sited the G.S. Order 300-35 (Body Cameras and that no one was informed that the videos has vital and classified evidence on them but they were informed in writing over 430 emails sent directly to the Rolesville PD starting with Chief Simmons (65 emails, Captain Haynes (65 emails), Investigator LT Williams (267 emails), Officer Apodaca (8 emails), and Secretary Ynclain (9 emails)

starting on 3/4/21 to YTD and verbally in meetings in their offices, lobby and over the phone. ---see screenshots from AOL that shows emails were sent to the RPD starting immediately after verbally communications failed. For the last year, on an average of 3-4 times daily, I requested this video and the 911 call logs but the RPD has refused even when I got two Attorneys', the investigator LT Williams would tell these Attorneys that the video never existed and would laugh behind these attorney's back to me or afterwards would say: Chief Simmons has the videos in custody and you'll never getting it, period!

- 7) On February 24<sup>th</sup>, 2022 the Rolesville PD Investigator LT Courtney Williams stood outside my house, in the driveway and I invited him inside my home to ask a few questions and the LT said: Ms. White, Sheriff Simmons isn't ever going to release that video; even if GOD & Country asked him too..., and it's differently never going to be given to you, a Judge or anyone else in Wake County Courts for evidence, we are just going to continue to say it's been purged/ deleted/ something to that notion and because we are the police no one is ever going to question us or ask for proof that's only you asking for proof; even thou, Sheriff Simmons still has a copy of the Hacking - Confession video's in his Custody "ONLY" at this point. You should understand by now, what's going on here, even if you don't..., that video will never see the light of day, period.
- 8) Currently, Chief Simmons is having his staff to hacking and deleting all of my AOL emails off of Chrome and Google, as under the Chief's instruction his officers are DELETING my evidence in the 430 emails sent to Rolesville PD (they have deleted all emails except 2 emails, per LT Williams)and now, the PD is DELETING my Verizon texts, pictures, screenshots, CPI videos and emails sent via my phone apps.
- 9) Just a week ago on 3/7/22 at the Rolesville PD station, one of his female Officers came upfront in the lobby to speak with me and she stated: you know Ms. White, you wouldn't have to worry so much about us DELETING the wrong emails in your AOL or Verizon..., if you just gave us your cell phone and allowed us to simply reset the phone back to its original iPhones Manufactured Setting and wipe it clean. I laughed and stated, so the Rolesville PD is the ones deleting my AOL files on Chrome and Google, she's said: yes and we wouldn't have to be deleting anything, if you just gave us your phones..., then I asked her are the GPS coordinates the police

is using plays off of my homes latitude and longitude coordinates, and the coordinates interacts with GPS maps..., right? So is these the RPD surveillance camera images, I'm seeing inside of my home? And she said: Yes of course it is..., she stated. I said: I'm finding these camera images all over my home: inside of my 87 yrs. old Mother bedroom/bathroom, my Master bedroom, my shower/bathroom, my toilet room, my master closet, Livingroom, Kitchen and even in my Garage, is that the Rolesville PD too? She said: Yes, of course it is but you can make it easy on yourself, if you just turned over all your evidence and allow us to DELETE everything at once. Why are you deleting emails back to 2018, to get your attention and we didn't move to Rolesville until 12/31/19 to get your attention, again and that possibly that we can do anything as officers. I said: You're hilariously not funny, I just wanted to know who's deleting my files and walked out.

10) Chief Simmons of the Rolesville PD is aiding and abetting in criminal behavior by covering up criminal activities against me, my Family and destroying our property and break-in our home over 3 dozen times with the Master key that Ryan Perry of ICG Homes never turned over to us during closing on 12/31/19. Per Michelle Larschield, I have a neighbor stating on Officer Apodaca bodycam (video that their friends gave her husband Craig my personal Account number, IP address, Password and ID, SSN, DOB, banking information and passcodes to get into all of my personal accounts and home accounts with Spectrum, CPI and ADT, etc., so they could steal my money (\$25K in cashier checks, \$1,158 in cash) and account information, why? It's not like anyone paid these bills you've broken into. Here's where the Rolesville Police comes in at regarding the video comments is when Michelle Larschield states on the BodyCam video that the Rolesville PD has been helping to cover up criminal activities against me, Mommie and my family since we move in next door to their family on 12/31/19.

11) Defendant is asking the Superior Court to sanction the Rolesville Police Department with the following criteria's:

- a. In order to get Chief Simmons attention the court should charge the station w/a \$5,000 per day fine until Chief Simmons adheres to the Superior Court Orders to turn over the three (3) Hacking - Confession video from his 3 officers an the 911 call log; which apparent is vital evidence to prove who's actually at fault and telling

the truth in court because the Plaintiffs own Attorney P. Feldman already told Judge David Baker on 1/3/22 that all of the complaints against the Defendant are fabricated lies, intentionally made-up to give the appearance of negative comments and plaintiff's attorney told the court, ALL the Facebook posts were created by Craig & Michelle Larschield and Ryan Perry. And that the Defendant did not create any of these posts offered in evidence but Plaintiff's attorney confessed her clients are creating the posts to give the appearance of, but Ms. White is 100% innocent, so why is the Chief protecting these people by ignoring and refusing to turn over vital evidence to a court that he's bound to uphold these laws at all times. These people stole, damaged and destroyed over \$43,621 worth of my property and belongings, YTD.

- i. Arrest and put Chief Simmons in custody of the Wake County Police Dept for ignoring the Superior Court Orders before his police station. Since Chief Simmons is defiant and illustrating his denial by showing his personal disposition that they will challenge, resist and fight back against any and every superior court order that comes their way, in order to protect himself and fellow officers from criminal charges.
  - ii. Defendant is requesting the court to allow the Wake County Police to arrest Chief David Simmons, Captain Richard Haynes and LT Courtney Williams until the Rolesville Police SGT left in charge turn over these critical and vital records requested by two Superior Court Judges, thus far.
- b. Or the Superior Court could allow the District Attorney or State Bureau of Investigations to go in immediately before Chief David Simmons delete and destroy any more evidence in this matter.
  - c. Or the Superior Court could make the Plaintiff Attorney P. Feldman with the Smith Debnam law firm just turn over the 3/3/21 Hacking - Confession Video that way the court have exactly what the Plaintiff has.

12) Obviously, when the Plaintiffs wife Michelle stated that on 3/3/21 during the taping of the Hacking - Confession Video that the Rolesville PD has been covering up their crimes,

maybe she was stating the Sr. Mgmt. of the Rolesville PD because the Chief is differently delete my emails on AOL and deleting texts/pictures/documents under my Verizon account as hard as they can.

13) See attached items Stolen from the home or damaged that was reported to the 911 dispatcher and Rolesville PD, that's why Chief Simmons is not releasing the 196 calls to 911 because it confirms what was stolen out of the home and what got damaged or destroyed outside of the home.

1) Plaintiff's attorney told Judge Baker:

- a. the 3/3/21 Hacking - Confession Video does exist,
- b. her clients both are visually in the video,
- c. she has a copy of the video,
- d. she's seen the entire video,
- e. her clients Craig & Michelle Larschield and Ryan Perry have all lied to the courts,
- f. her clients have lied to 6 or 7 DV Judges since 3/5/21,
- g. all complaints filed against the defendant are fraudulent filings and evidence created by her clients, to hurt and harm the defendant,
- h. Her clients are liars and most continue to lie,
- i. Defendants' testimony is 100% accurate and more occurred to her that she doesn't even know about...
- j. Michelle did state the Rolesville PD has been covering up their crimes against the defendant and her family,
- k. Michelle is commenting verbally that her husband Craig hacked the Defendants personal, home, social media profiles, and security system, etc.,
- l. Michell is commenting verbally that Craig hacked the defendants home telephone, can hear both sides of the conversation and can see inside the defendant's home,
- m. Defendant did not write any of the Facebook posts in questions that have negative commentary in them,
- n. her clients wrote all the Facebook posts and not Ms. White,
- o. her client just lied to Judge Bakers face,
- p. her client knows they're perjuring themselves with each lie,
- q. defendant hasn't done anything wrong,
- r. her clients did damage, destroyed and stole the defendant property and belongings; etc.
- s. her clients fraudulently made up lies on the defendant,

- t. her clients did everything the defendant stated occurred to her and more,
- u. her clients did broke-in the home of the Defendants, stole items, poison her drinks/food/plants, etc.
- v. her clients did pour chemical throughout the yard of the defendants,
- w. her clients lied to the following Domestic Violent Judges: Eagle, Sasser, Bell, Walyck, Stephens, Stevens, Magnum, and Baker etc.,
- x. Plaintiff's Attorney told Judge Baker, her clients hate Ms. White and is sitting her up with fabricated evidence before Judge's: Eagle, Stevens, Sasser, Stephens and Magnum is buying their lies and granting 50cs against the Defendant and she has not done anything wrong!
- y. Plaintiff Attorney admitted, affirmed, confessed her clients perjured themselves and most continue lying at this timeframe. Go big or go home one...!
- z. Defendant is asking the Superior Court to levy any known law against the Chief of Rolesville Police Dept to make them turn over this evidence
  - or make the Plaintiff's Attorney turn over their copy of the 3/3/21 Hacking - Confession Video to the Superior Court, since they filed the 3/5/21 initial Domestic Violence compliant stating the Defendant violated them on 3/5/21, make the plaintiff give up the Hacking Confession Video in question.

4) Rolesville PD has willfully violated the terms and conditions of the Order 22cvd01444 and every law they are bound to uphold and protect in their community when they became part of the criminal behavior against the Defendant and they should be held accountable for the Rolesville PD involvement in these crimes, as follows

The actions of the Plaintiff have been willful, without just cause, excuse or provocation and the Rolesville PD have the ability to comply with this Superior Court's Order but just have refused too; therefore, they should be held in contempt. Defendants asking the Judicial Branch to hold Chief Simmons responsible because he over the Rolesville PD and he's the bottleneck stopping the release of vital evidence and the 911 call logs. Neither request from the Court has been turned over.

WHEREFORE, Plaintiff/Defendant prays the Court as follows:

- 1) That the Court enter an Order holding Rolesville Police Department in contempt of Court.
- 2) That the Court enter an Order granting Defendant the following:
  - a) Under NCGS Chapter 132 1.4A(f) Person authorized to receive disclosure. and (g) General, it gives the court criminal jurisdiction over any of its State or Local Agencies, therefore, it can hold Rolesville PD accountable for ignoring these orders.
  - b) Grant Wake County to arrest these people for not adhering to the Superior Court Orders,
  - c) Grant Wake County DA to assess and issue charges for perjury
  - d) Grant SBI to step-in and assess this matter, and charge people accordingly,
  - e) An Attorneys Admission of Guilt for their client is rarely ever given in a court of law, but this plaintiff's attorney admitted and confessed the Plaintiff is lying on the Defendant and must continue to lying at this timeframe to Domestic Violence Judges.
  - f) Grant Defendant a Protective Order against Craig and Michelle Larschield, and Ryan Perry.
  - g) Grant G.S. 132-1-4A(f) Person Authorized to received disclosure and G.S. 1.4A(g) General.
  - h) Grant Dismissal of Actions, G.S. 1a-1, Rule 41(a) and pursuant to NC Rules of Civil Procedures and Evidence, Chapter 1A, Rule 1-84 and Chapter 8C when evidence is fabricated you have no case because in this matter the plaintiffs own attorney has acknowledged their clients made up all the negative evidence and lies intentionally to harm the Defendants because they know certain judges that would have their back, regardless of the evidence before the court.
  - i) Rule 11 of NC Rules of Civil Procedures to sanction its intended to make sure when an attorney or party submits a legal document it's believed to be in "good faith" and is an honest assessment of the legal matter and not just lies. Defendant is asking the court to sanction these people for lying and wasting the courts time.
  - j) Grant Dismissal of all 50c's levied against Defendant, Gwendolyn White
  - k) Hold Plaintiff accountable for lying in 21cv002424, 21cv003560, 21cv016397, 22cv00198; etc.

- l) Grant Rule 60. Relief from Judgement or Order, because Plaintiffs own attorney told Judge Baker the filings are fraudulent and made up with lies fabricated by the Plaintiffs.
  - m) Grant Sanction - Rule 11, allocate sanctions upon the Rolesville Police for ignoring court orders.
  - n) Grant Rule 12(b) (6), a Protective Order for me and my family against these people that have stalked, abused, harassed, tormented, terrorized, followed, broke-in our home, stole our belonging and cash out of our home,
  - o) Grant a request for these people to be held for perjury charges.
  - p) Grant reimbursement of \$43,621 for all items damaged, destroyed and stole out of our home and from us,
  - q) Grant a full dismissal of pursuant to NC Rules of Civil Procedures and Evidence Achapter 1A, Rule 1-84 and Chapter 8C.
  - r) Restore Defendant and her family by reimbursing them the \$43,621 stole from them with the fines from the Contempt of Order violations, since Chief Simmons wont turn over vital evidence.
- 3) Hold the Rolesville PD Chief David Simmons solely responsible and accountable for his police stations actions and behavior in ignoring the Superior Court Order under 22cvd01444 to turn over vital evidence.
  - 4) For such other and further relief as to this Court may seem just and proper.
